Promotion Terms and Conditions

- Not available in conjunction with any other offer or discount.
- Promotion is only open to Australian residents who (1) hold a current 2011 membership for the Port Adelaide Football Club (**Club**); and (2) are a new Adam Internet customer; and (3) purchase an Adam Internet 24 month ADSL or VDSL EzyChoice plan including SuperChoice and Naked plans (**Internet Service**) between 1 July and 30 September 2011 (an **Eligible Claimant**).
- Customer must quote a valid Club membership number at the time of application in order to process order. Adam Internet will not accept the Club membership number at a later time even if the installation has not yet occurred. The Club membership number will be verified with the Club prior to voucher being distributed.
- Customer cannot cancel the Internet Service if verification shows the Club membership number is not valid.
- Voucher will be posted to nominated address of account holder. Eligible Claimant will receive one voucher for a 2011 season Port Adelaide Football Club 'home' Guernsey (**Guernsey**) via mail after the Internet Service has been connected. Eligible Claimant can redeem the voucher in person only at Power Megastore, located at Brougham Place, Alberton, SA 5014. Eligible claimant may be required to show photo identification upon redemption.
