**Service Agreement**

In addition to the following specific terms & conditions, the applicant also agrees to the Adam Internet standard terms and conditions. The applicant may view these terms & conditions at <http://www.adam.com.au/terms.php> or may request a written copy NOW before signing.

**EZBiz Dialup Specific Terms & Conditions**

1. EZBiz Dialup is a 12-month contract, with an additional \$99 disconnection if cancelled with-in 12 months.
2. Allowed maximum storage for email is 5MB per mailbox, maximum storage for web hosting is as per the plan selected. Applicant is responsible for any charges incurred as a result of exceeding the maximum allowed storage included as part of the service.
3. Allowed maximum outgoing traffic from Applicant's web site is 3000MB per month. Any excess traffic may be charged at \$0.12 / MB.
4. Applicant will not use the Adam Internet Service to distribute illegal or copyrighted material.
5. Applicant will not use the Adam Internet Service to send mass or unsolicited email. There are penalties for breaching this condition, as detailed in the Adam Internet standard Terms & Conditions.
6. Although Adam Internet takes measures to ensure service reliability, no guarantees are made that any portion of the service will be active at any given time, or that the service provided will be without downtime. Adam Internet cannot be held liable for any loss or disappointment you may suffer as a result of any faults or interruptions in Adam Internet's service
7. Applicant is fully responsible for the maintenance, upkeep and uploading of the web site. The applicant acknowledges that Adam Internet staff cannot upload, modify or delete portions of a web site, with the exception of web sites developed by Adam Internet and maintained as part of an ongoing agreement.
8. Although Adam Internet takes a nightly backup of all web sites hosted under a business service, the Applicant is fully responsible for keeping their own backup copies of any web site(s) hosted by Adam Internet. Should a site need to be restored from backup, Adam Internet will take steps to ensure data integrity, however no responsibility will be taken for any loss of data. Applicant indemnifies Adam Internet from any loss of business or income due to any fault within the Adam Network.
9. If, though no fault of Adam Internet, the Applicant requires a web site to be restored from nightly backup a charge will be applied to the Applicant's account. This charge is set at \$250 or \$88 per hour, whichever is the greater.
10. Applicant understands that this domain hosting service agreement is to rent space and additional services (if applicable) on one of Adam's web servers. The service provides access to the allocated space on the web server using the username and password supplied. Adam Internet does NOT offer free technical support to assist with uploading files, support with FTP programs, support for scripts, programming or web design. Technical assistance is only available by email to [webdesign@adam.com.au](mailto:webdesign@adam.com.au), at the cost of \$55 per hour or part thereof.
11. You must comply with the Acceptable Use Policy and you acknowledge and agree that we may exercise any of the rights specified in the Acceptable Use Policy.
12. You must do the following in relation to your Adam Internet's Dialup service: adopt appropriate measures to ensure the security of your account information, password and your data; and advise us in a timely manner if you have reason to suspect that the service is being used contrary to the applicable Terms and Conditions or the Acceptable Use Policy.
13. You agree not to connect any equipment other than the Equipment authorised by us

14. Applications will only be accepted with credit card details that enable a successful initial payment, or upfront payment for all setup and third party charges.
15. If specified by you, your credit card will be used for all charges relating to this service. If credit card billing is not specified, we will invoice you for the ongoing costs relating to your service, and only use your credit card for any set-up, hardware or third party fees.
16. Your credit card details will be kept on file, and should any invoices remain unpaid for a time deemed longer than reasonable, you authorise Adam Internet to charge these amounts to your credit card.
17. Your data usage is counted on incoming data only, except when outgoing traffic is greater than incoming traffic, in which case you are charged for outgoing traffic only. Any excess traffic above your allowance will be billed monthly at the current rate. This rate is fixed for 30 days and is subject to change without notice.
18. You warrant that you are the same end user acquiring a standard telephone service on the line to which your application relates or that you have obtained authority of the legal lessee of the standard telephone service.
19. You acknowledge that where you have asked us to supply the Adam Internet's Dialup Service you acknowledge that there may be a minor disruption to you or the legal lessee's standard telephone service during provisioning; and you acknowledge that certain incompatible products may not be available to you.
20. You agree that you will be liable for the EZBiz Dialup payment Schedule in accordance with your contract term. In the event that the legal lessee terminates the standard telephone service, Adam Internet excludes liability for the termination of your service; but you agree to continue the payment of the payment schedule for the term of your current contract.
21. You acknowledge that should you default on your scheduled monthly payment, and, if we are unable to secure a suitable payment, debt recovery services will be used to recover any amount outstanding plus the setup fee of \$99. Please note that you may be liable for any financial institution charges and collection fees including but not limited to solicitors costs or a collection agent appointed by Adam Internet.
22. Should you wish to cancel this account and the account has been active for more than 12 Months you may cancel the account with 28 days notice. An additional fee of \$99 is payable if the account has been active for less than 12 Months and the set-up fee was waived at time of joining, in addition to any part of the current 12 month contract that is outstanding at time of cancellation.
23. These terms and conditions are subject to change and a current copy can be provided on request.
24. Adam Internet may in some instances carry out credit checks on you with credit reference agencies or we may follow up references. The fact that Adam Internet has carried out such a credit check, and in some instances the nature or results of the credit check, will appear on the agency's register. You can obtain a copy of your register entry by writing to the relevant credit reference agency, sometimes on payment of a fee.
25. Applicant is fully responsible for the upkeep of any third-party licences/renewals –for example domains, secure certificates etc. In some cases, Adam Internet may offer a service to manage the renewals and maintenance of such third-party objects. In these cases, we act as an agent only and the final responsibility still lies with the Applicant.
26. Adam Internet cannot be held responsible for any third party charges relating to the use of the service. This includes, but is not limited to, telecommunications charges such as STD or ISDN calls.
